Subject: Redesigning and Redevelopment of Website of all units of Kendriya Vidyalaya Sangathan.

Madam/Sir,

As you are aware that at present all units of KVS are having their own website which are

- (i) Hosted and managed on Private Server
- (ii) Non-compliant with Govt. of India Guidelines for Websites (GIGW)
- (iii) Without Security Audit by Cert. in
- (iv) Without STQC Certification.

According to DEIT, E-Governance Section, 6 CGO Complex, Electronics Niketan, Government of India directions, all websites should be GIGW Compliant (Ref. Letter no. 3(14)/2009-EG II Vol. II dated 28/05/2015)

All websites have data in public domain and prone to hacking, malware infection and without security clearance. Keeping all these vulnerabilities in focus the Competent Authority, KVS has decided that all websites of KVS must be GIGW complaint. Henceforth the websites of all units of KVS i.e. KVS(HQ), 25 ROs, 05 ZIETs, 1180 KVs will be **Redesigned and Redeveloped on Centrally Managed Common Platform** with hosting at **NIC Server**. The websites will also have Dynamic Content like enrolment, vacancies, infrastructure etc. This project has been awarded to NICS I empaneled vendor M/s. Unecops Technologies Ltd in April 2018 with 10 months of delivery period and one year of AMC from the date of actual launch.

For successful execution and rollout of the project, your active, effective and time bound contribution shall be required in providing the nicely written/edited content from the Kendriya Vidyalayas/ Regional Offices/ZIETs. In this regard you are requested to take following actions immediately:

- (i) Constitution of **Regional Website Committee** having following members
 - (a) One Assistant Commissioner – Coordinator (Preferably who is in-charge of KV Shaala Darpan)
 - (b) PGT (Comp Sc.)- 05 (Who will be assigned 8-10 KVs for collection of data from schools)
 - (c) PGT (English) -01 : To ensure **error free** English language content to be posted on website.
 - (d) PGT (Hindi) -01 : To ensure **error free** Hindi language content to be posted on website.

Similar Committee may be constituted at Each ZIET also.

- (ii) Instead of one year contract with the present vendor Eight months contract may be signed extendable till the actual launch of website of that Unit. Instruction in this regard may be circulated to all Kendriya Vidyalayas.

You will be informed soon about the name of vendor's representative who will report to you and meet the committee for collection of data/format to be incorporated in the websites.
